Memorandum of Agreement-Municipal Service

DATED FOR REFERENCE THE 03 DAY OF December, 2008

BETWEEN:

OKANESE FIRST NATION

AND

STAR BLANKET FIRST NATION

WHEREAS OKANESE FIRST NATION requires provisions of potable treated water for the west end residents (detailed on the attached drawing) and STAR BLANKET FIRST NATION can provide this water from their Water main located 1.5 km east of the west end village.

THEREFORE the parties agree that OKANESE FIRST NATION can make connection to the STAR BLANKET FIRST NATION Water main (connection point shown on the attached drawing) and run this line to the existing fourteen west end residents and future residents as required.

THEREFORE the parties agree that STAR BLANKET FIRST NATION will provide the potable water and pumping to deliver the water to the noted residents and OKANESE FIRST NATION will maintain the water line from the curb stop adjacent to OKANESE FIRST NATION.

THEREFORE the following rates will apply:

October 2003-March 31, 2004	\$300.00 x 14 units
April 1, 2004-March 31, 2005	\$300.00 x 14 units
April 1, 2005-March 31, 2006	\$300.00 x 14 units
April 1, 2006-March 31, 2007	\$300.00 x 14 units
April 1, 2007-March 31, 2008	\$350.00 x 14 units
April 1, 2008-March 31, 2009	\$400.00 x 14 units
April 1, 2009-March 31, 2010	\$400.00 x 21 units

OKANESE FIRST NATION and STAR BLANKET FIRST NATION will meet on an annual basis, preferably August or September of each year, to review and update rates and any other related water issues pertaining to services.


This agreement is in effect until terminated by mutual consent of both parties.
